

2023 Annual Tuition Fees

Annual Tuition fees cover tuition, exercise books, digital subscriptions as required, text book hire and some excursions.

Sibling Discounts are applicable to families who have more than one child attending any NT Christian School campus. The 1st child is the eldest child. Discounts apply to tuition fees only. See further details at the end of this document.

NT Christian College issues all fees and charges via FACTS – our online fee billing system. FACTS provides a consistent, reliable and secure online payment system providing payment plan options and online account maintenance. FACTS also allows families to view account status, monitor payments, or update financial and personal information online. Families are required to establish their FACTS Payment Plan (and pay deposit) to secure their enrolment place, confirm acknowledgement and acceptance of the Conditions of Enrolment prior to commencement at the College.

NT Government Back to School Payment Voucher

Historically¹, the NT Government offers a \$150 *Back to School Voucher* per child from Transition through to Year 12, per year. This voucher can be used for the following:

- School Fees
- School Uniforms
- Year 12 Jersey
- Year 12 Formal
- Camps

Back to School Vouchers are issued at the start of Term 1, are only applicable to students who are enrolled at the school in Term 1 and need to be redeemed during the same school term.

The following deposits/fees are required in addition to Annual Fees:

¹ The College often only receives confirmation of the Back to School Payment Voucher program and it's value in early January of each year.

Excursion and Camp Fees

Excursions and Camps are an integral part of school curriculum and attendance is compulsory. Camp fees are itemised and are visible by logging into your FACTS online account. Payment is compulsory and is non-refundable. The relevant Head of School should be contacted to discuss extenuating circumstances.

Enrolment Application Administration Fee

A fee of \$40 per family covers administration costs to process enrolment applications if your family is not currently enrolled at one of the NT Christian Schools campuses. This fee is to be paid on lodgement of the enrolment application forms and is non-refundable. You may be exempt if your children attend another NT Christian School campus.

Student Deposit

A non-refundable deposit of \$150 per student is to be paid upon offer of a place in order to finalise the child's enrolment. This deposit is recognition of your acceptance of our offer of enrolment. Payments are made through FACTS secure online billing system.

Working Bee Levy

NT Christian College values and encourages parent involvement. Parents are required to be involved in 6 hours of school service inside or 4 hours of school service outside per year. A levy of \$220 per family is charged when the annual fees are levied. Over the course of the year as families complete their hours, the \$220 fee will be credited to the family account. Hours worked are to be recorded at the front office. Unfortunately, extra hours cannot be rolled over to the following year.

Sibling Discounts

Sibling discounts are applicable to families who have more than one child attending any NT Christian School campus. The 1st student is the eldest child, discounts are applied to students in age order (eldest to youngest) and to tuition fees only.

1 Child = 0% discount

2 Children = 15% discount for each child

3 Children = 30% discount for each child

4+ Children = 100% discount for the 4th child (and subsequent children) and 30% discount for each of the first 3 children.
